



Minutes of the meeting of the **Planning Committee** of the Council held on Thursday **26 June 2026** at 9.30 am at the Wonersh Sports Pavilion.

P14/15 027 To receive and approve apologies for absence.

The Committee received and approved apologies from Cllrs M Band, B Holtom, L Healy and C Smith; and from Mr K Garvey, Clerk to the Council.
