While noting that the combined floor area of the proposal is less than that of the original the Committee agreed that the reduction in floor area of the three small units in effect removes habitable space from the Borough's housing stock. It agreed that this is contrary to the spirit of the NPPF and to the implicit basis of the forthcoming Borough Local Plan. It agreed to object to the proposals on this basis.
